VILLAGE OF ST-PIERRE-JOLYS BY-LAW NO 2011-13

BEING A BY-LAW OF THE VILLAGE OF ST-PIERRE-JOLYS TO ESTABLISH AN INCENTIVE TO ENCOURAGE THE REPLACEMENT OF LESS EFFICIENT TOILETS WITH HIGH EFFICIENCY TOILETS

WHEREAS Section 261.2(1) of The Municipal Act provides as follows:

A Council may by by-law establish financial assistance programs.

AND WHEREAS Section 261.2(2) of the Municipal Act provides as follows:

A financial assistance program may include provisions

- (a) prescribing the types, locations or classes of premises eligible for financial assistance, which types, locations or classes may be based on the age, assessed value or occupancy of the premises, or other criteria;
- (b) prescribing the amount, of the manner of calculating the amount, of financial assistance for each premises or each type, location or class of premises;
- (c) prescribing the types of renovations and costs associated that are eligible for financial assistance;
- (d) establishing terms and conditions under which financial assistance may be provided or terminated, including establishing criteria for determining
 - (i) the amount, or the manner of calculating the amount, of financial assistance,
 - (ii) the maximum annual financial assistance, and
 - (iii) the year or years during which financial assistance may be paid out or applied

The Council of the Village of St-Pierre-Jolys is of the opinion that it is in the best interest of the Village to create this incentive which will extend the life of the lagoon.

THEREFORE BE IT RESOLVED THAT Council for the Village of St-Pierre-Jolys enacts as follows:

- (1) The financial assistance program takes effect on October 15th, 2011
- (2) Reimbursement to a maximum amount of \$50.00 (fifty dollars) towards the cost of purchase and installation of a high efficiency toilet. A representation of original receipt is required as proof of purchase.
- (3) First one hundred (100) toilets qualify up to a maximum program cost of \$5,000.

Conditions

To qualify for the financial assistance program, all of the following conditions must be met:

- (a) Registered owner must not be in violation of any of the Village's by-laws.
- (b) Registered owner must not be in arrears on any accounts
- (c) Registered owner must retro fit the toilet(s) to low-flush high energy efficient or dual flush type toilet(s) (8 liters or less)

In order for a grant to be provided the person eligible must:

- (1) Apply in writing for the grant
- (2) Provide a copy of the receipt for the purchase of the low-flush or dual flush toilet(s) that has been installed in a property located in the Village of St.-Pierre-Jolys. Receipt must be dated October 15th, 2011 or later.
- * New construction excluded.
