- Hall Rental Fees:

 - Full Day Rental (7.5+hrs) including kitchen use:
\$600 flat fee (tax included) with a \$300 deposit
- No Smoking or vaping in building
- All consumables and corkage (ie: cups, napkins, ice, cutlery etc.) are provided by renter.
- If liquor permit is obtained for event, bartenders and security will be provided by Village of St-Pierre Rec Centre at a cost of \$125/bartender(2) and \$150/security(2)
- St. Pierre Rec. must receive \$300 down payment at the time of the booking **on full day rental only**. This payment will be held as a damage deposit and will be applied to the balance owing providing there is no damage. The renter accepts the responsibility for any unnecessary damage and agrees to pay for any such damage.

 - Credit Card (including a fee of \$9.80) (Call 204-433-7832 ext. 2 to make payment)
 - Invoice will be sent following the event for the remainder of the rental by email.
 - Cleaning of the tables is the responsibility of the renters.
 - Decorating and setup is to be done by renter prior
 - Decorations are to be hung on hooks that are installed on the walls around the hall.
- Any extra decorations must be approved by manager.
