

## VILLAGE OF ST-PIERRE-JOLYS By-Law No. 2024-02

Being a by-law of The Village of St-Pierre-Jolys to provide for the remuneration of members of the Council of the Village of St-Pierre-Jolys which repeals by-law 2021-8.

**WHEREAS** the Municipal Act, S.M. 1996, c.58, Section 124, provides for the remuneration of members of Council;

**AND WHEREAS** it is deemed expedient and in the best interest of the Village of St-Pierre-Jolys to provide for the payment of indemnities and certain expenses to members of Council;

**NOW THEREFORE,** the Council of the Village of St-Pierre-Jolys, duly assembled in open Council, enacts as follows:

- 1. **THAT** a yearly indemnity of
  - a) Nine Thousand Dollars (\$9,000.00 in 2024) & Ten Thousand Dollars (\$10,000 in 2025) be paid to the Mayor;
  - b) Seven Thousand Five Hundred Dollars (\$7,500.00 in 2024) & Eight Thousand Five Hundred Dollars (\$8,500.00 in 2025) be paid to the Deputy Mayor;
  - c) Seven Thousand Dollars (\$7,000.00 in 2024) & Eight Thousand Dollars (\$8,000.00 in 2025) be paid to each Councillor;
- 2. **THAT** the attendance of Council at the regular meeting of Council including all preparation work shall be included in the monthly indemnity and that members of Council be paid for any special meetings duly called by Council.
- 3. **THAT** each member of the Council, if authorized by Council specifying the purpose, to go on a journey, on the business thereof, shall be paid the actual expenses in connection with the same, together with an indemnity of \$21.37 per hour, to a maximum of 8 hours per day or a maximum of \$171.00 per day.
- 4. THAT the mileage rates for the Village of St-Pierre-Jolys be set at the same rate not lower than the National Joint Council Kilometric Rates for Manitoba. These rates apply only for the use of private vehicles on prior authorized non-committee government business taking place outside the corporate limits of the Village of St-Pierre-Jolys, as approved by resolution of Council or These rates apply to kilometers traveled in a private vehicle owned by or operated by the council member in the performance of his/her duties.
- 5. **THAT** each member of Council, if duly authorized by resolution of the Council to attend a meeting of
  - a) Association of Manitoba Municipalities; or
  - b) Such other organizations that in the opinion of the Council it is in the interests of the corporation to belong, shall be paid an indemnity at the same rate as shown in Clause 3 above hour plus the actual living expenses, and mileage at the same rate as shown in Clause 4 above, for traveling to and from such meetings.
- 6. The indemnities for a member of Council shall be prorated if the term of office commences or terminates on a day other than the last day of the month of said commencement or termination.
- 7. **THAT** each member of Council may be paid traveling expenses at a mileage rate as per kilometer as listed in Clause 4 above, each way travelled from his/her place of residence to the place of the meeting and return to his/her residence to be allowed only once for each meeting he/she attends.
