The following items may be required to process your building permit application. Please ensure all required documents are submitted with this application:

- Site Plan including a Survey of property or Staking certificate, location of proposed building/structure, including dimensions of building/structure and distances from all property lines to the proposed structure.
- Building/Structure Plans including both either a digital copy or two paper copies with clearly marked dimensions (a large set must be available on-site), sealed by a Professional Engineer (required and must appear on 1 set of paperwork), and a Letter of Assurance from Engineer (when requested).

The Municipality reserves the right to request a current Building Location Certificate prepared by a Manitoba Land Surveyor for all permit request **THE APPLICANT FURTHER UNDERTAKES TO START CONSTRUCTION WITHIN SIX MONTHS FROM THE DATE OF THIS PERMIT.** The applicant undertakes to observe and perform the provisions of all Dominion or Provincial Statutes or regulations, the applicable by-laws, schemes or regulations or order and plans continued in force pursuant to Manitoba Building Codes including any applicable Village of St-Pierre-Jolys Zoning By-laws, any agreements entered into such land, and all specifications or instructions issued by the duly authorized officers of the in respect of the work incidental to the subject matter of this application and if the permit involves of affects the placing of or the position of any building or structure on or in respect of land, to do all work so that the building or structure will be whole within the boundaries of the lot or parcel of land indicated in this application and to indemnify the Village of St-Pierre-Jolys against all losses, costs, charges or damages caused by or arising out of anything done pursuant to any permit issued under this application.
