VILLAGE DE/OF ST-PIERRE-JOLYS

BY-LAW NO. 2019-5

BEING A BY-LAW OF THE VILLAGE DE/OF ST-PIERRE-JOLYS TO PROVIDE FOR THE CARE AND MAINTENANCE OF THE ST-PIERRE-JOLYS CEMETERY.

WHEREAS SECTION 232(1) OF THE Municipal Act states in par that:

"A council may pass by-laws for municipal purposes respecting the following matters:

a) the safety, health, protection and well-being of people, and the safety and protection of property."

AND WHEREAS it is deemed necessary to provide certain care and maintenance of the Village of St. Pierre-Jolys Cemetery;

NOW THEREFORE the Council of the Village de/of St-Pierre-Jolys in open Council assembled, enacts as follows:

- 1. The digging and closing of gravesites and cremation sites must be done by Village de/of St. Pierre-Jolys employee.
- 2. Allow 2 hours between burials if more then one burial requested in one day.
- 3. That no person be allowed to place coverings or fenced enclosures on or around a gravesite.
- 4. That owners of cemetery plots be allowed to erect a headstone or marker for each grave.
- 5. That prior to erection of any headstone or marker for a grave, the site must be marked by a Village de/of St-Pierre-Jolys employee. Headstone base size <u>2 ft by 4 ft</u> maximum
- 6. That no trees or shrubs be planted on a grave.
- 7. That no glass containers be allowed in the St-Pierre-Jolys Cemetery.
- 8. Flowers, real or artificial, placed only on headstones are to be maintained by family or friends of interred.
- 9. That no ashes be sprinkled in the St-Pierre-Jolys Cemetery.
- 10. That all cremation urns be completely buried.
- 11. That no pets be buried in the St-Pierre-Jolys Cemetery.
- 12. Plots:
 - a. That as of the passing of this bylaw, plot sizes are as follows:
 - i. Each full burial plot is <u>4 feet by 10 feet</u>
 - ii. Each columbarium niche is 12" x 12" x 12"
- 13. That there is a limit of six cremation urns to be buried on one plot, given that there is a letter from the owner of the plot or the executor of the owner, along with the 1st page and last page of the will, of the plot giving permission to be buried on his/her plot.
- 14. That the marker for cremation urns shall only be plaques flush with the ground for maintenance purposes.
- 15. GPR Investigation:
 - a. GPR investigation If the Village is challenged on a grave site location, the client pays for the GPR cost unless the grave location is proven to be incorrect and results are contrary to the locations in the Village Cemetery book.
- 16. Fees to be established by resolution as needed.
